

PRETEXTOS PRINGOLES SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION.** The **Pretextos Pringoles Sweepstakes** (the "**Sweepstakes**") is an online entry only Sweepstakes that begins on 11/7/22 at 12:00:00 AM Eastern Time ("**ET**") and ends on 12/20/22 at 11:59:59 PM (ET) (the "**Promotion Period**").
2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are sixteen (16) years of age or older at the time of entry. Eligible entrants who are less than the age of majority in their state of primary residence must have a parent/legal guardian's permission to enter the Sweepstakes. Employees, officers, and directors of Kellogg Company ("**Sponsor**"), its parent company, affiliates, subsidiaries, partners, advertising, promotion and other agencies (collectively, "**Promotion Entities**") and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply.
3. **HOW TO ENTER.** During the Promotion Period, you may enter by going online to www.pringoles.com ("**Website**") and follow the instructions to complete your entry into the Sweepstakes. As part of the entry process, you must enter an "excuse" of how you (the entrant) plan to avoid commitments in order to watch the matches of the soccer event of the year.

Limit one (1) entry per person/email address during the Promotion Period. No automated entry devices, bots and/or other programs and/or software are permitted for entry. No mechanically reproduced, altered, forged, or facsimile entries will be accepted. All entries become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic. Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes.
