

PRINGLES™ “SHOW YOUR ‘STACHE FOR A STASH” SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION:** The *Pringles*™ “Show Your ‘Stache for a Stash” Sweepstakes (the “Sweepstakes”) is a social media Sweepstakes that begins on 3/15/23 at 8:00:00 AM Eastern Time (“ET”) and ends on 4/4/23 at 8:00:00 AM (ET) (the “Promotion Period”).

Throughout the Promotion Period, eligible entrants will have the opportunity to complete an in-feed Instagram post with a photo or video of themselves (the entrant) that shows them and their mustache (note: mustache can be grown, drawn on, etc.) along with the Hashtag #PringlesMarchMustacheEntry (the “Hashtag”) in order to enter the Sweepstakes (the “Entry”), as more fully set forth below. For purposes of this Sweepstakes, a “Day” is defined as any 24-hour period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). There will be twenty-five (25) prize winners in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and posting an Entry (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellogg Company (“Sponsor”), which shall be final and binding in all respects.

2. **ELIGIBILITY:** Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia and are eighteen (18) years of age or older at time of entry. Employees of Kellogg Company, its parent company, their subsidiaries, affiliates, advertising, promotion and other agencies (collectively, the “Promotion Entities”), and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state, and local laws and regulations apply.
3. **HOW TO ENTER:** You may enter the Sweepstakes via Instagram by going to <http://www.instagram.com> and log into your Instagram account. Then, complete your Entry by completing an in-feed Instagram post with a photo or video of yourself (the entrant) that shows you and your mustache (note: mustache can be grown, drawn on, etc.) along with the Hashtag #PringlesMarchMustacheEntry. Entry must be completed from the entrant’s non-private Instagram account; you must include a photo or video of yourself showing your mustache; and you must post the Hashtag in your Instagram in-feed for your Entry to be eligible as an entry into the Sweepstakes. You must be a registered Instagram member to enter. Instagram account registration and Sweepstakes entry is free.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Instagram. Limit one (1) Entry per person, per Day in the Sweepstakes.

Each Entry must meet the following “**Entry Requirements**” (any Entry that, in Sponsor’s sole and absolute discretion, violates the following criteria will be disqualified):

- Entry must be posted to a non-private social Instagram account; Instagram accounts can be obtained for free at <http://www.instagram.com>;
- Entrant must be the rightful owner of the Instagram account associated with the Entry;
- Entry must comply with Instagram’s terms and conditions as posted on its platform;
- Entry photo and/or video must not contain any other individual(s) other than entrant;
- Entry must NOT contain any derogatory references to any of the Promotion Entities;
- Entrant must be the rightful owner of the Entry, including the original photo and/or video, included with the Entry;
- Any video included as part of an Entry must be no longer than 60-seconds long and not exceed size limit per the social media platform’s requirements;
- Entry must NOT contain any material that infringes or violates any right of a third-party including copyright, patent, trademark, trade secret or other proprietary rights. For example, Entry should NOT contain reference to sports team logos, celebrities, names or logos of businesses, copyright protected music or lyrics, or clips from television shows or movies;
- Entry must NOT include third parties/people, who have not expressly authorized in writing the entrant to feature their name, image, likeness or voice in the Entry or otherwise use such name, image, likeness or voice in accordance with these Official Rules (if applicable, any selected winner may be required to verify such authorization in the form of a release);
- Entry must NOT contain subject matter which is, or could be considered, in the sole discretion of the Promotion Entities, obscene, pornographic, violent (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), defamatory, libelous, discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g., illegal gambling, underage drinking, substance abuse, computer hacking, etc.), offensive, threatening, profane, hateful, degrading, harassing, or otherwise unlawful, tortious or objectionable;
- Entry must NOT contain any content that promotes any particular political agenda or message;
- Entry must NOT contain any personal identification, such as personal names or e-mail addresses other than the entrant (if applicable);
- Entry must NOT communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate;
- Entry must NOT violate any law;
- Entry must NOT contain any content that is protected by copyright (without the express prior written consent of the owner of such right), including any music or include any recognizable locations or include names and/or descriptions of any copyrighted media production, including, without limitation, films, books, television programming, etc., or identifying descriptions of any media property; and
- Entry must NOT contain any derogatory references to any of the Promotion Entities

Proof of entry is not considered proof of delivery to or receipt of such entry. Furthermore, Sponsor shall have no liability for any entry that is lost, intercepted or not received by the Sponsor.

4. **WINNER SELECTION AND NOTIFICATION:** Twenty-five (25) prize winners will be randomly selected from all eligible entries received during the Promotion Period on or about 4/6/23 by Sponsor or its designee, whose decisions are final. Each potential winner will be the entrant of the Entry that is associated with the entry that is randomly selected as a winning entry, subject to eligibility verification. Potential winners will be notified via direct message within seventy-two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within two (2) business days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners in accordance with the above procedure, after which the prize may go unawarded if it remains unclaimed. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected.
5. **REPRESENTATIONS AND WARRANTIES/INDEMNIFICATION:** Each entrant represents and warrants as follows: (i) the Entry is the entrant's own original, previously unpublished, and previously unproduced work; (ii) the Entry is wholly original with the entrant; and (iii) the Entry does not and will not violate any applicable laws, and is not and will not be defamatory or libelous. By participating in the Sweepstakes, each entrant unconditionally warrants that his/her Entry complies with and abides by the submission requirements as provided in the Official Rules. Each entrant hereby agrees to indemnify and hold the Promotion Entities harmless from and against any and all third-party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of entrant hereunder.
