

## **PRINGLES™ X CAVIAR SNACK PLATE GIVEAWAY**

### OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION:** The *Pringles*™ x Caviar Snack Plate Giveaway (the “Sweepstakes”) is a social media Sweepstakes that begins on 7/10/24 at 12:00:00 AM Eastern Time (“ET”) and ends on 7/10/24 at 11:59:59 PM (ET) (the “Promotion Period”).

Throughout the Promotion Period, eligible entrants will have the opportunity to “like” a post by the *Pringles*® Instagram account (@pringles); follow @pringles and Goobs Ceramics (@goobsceramics) on Instagram; post the Hashtag and tag a friend (as defined below) on Instagram in response to the Sweepstakes post on 7/10/24 by @pringles (the “Submission”), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and completing a Submission (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova (“Sponsor”), which shall be final and binding in all respects.

- Submissions must be posted to a non-private social Instagram account; Instagram accounts can be obtained for free at <http://www.instagram.com>;
