

PRINGLES™ X BRÜMATE GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. **PROMOTION DESCRIPTION:** The **Pringles™ x BrüMate Giveaway** (the “**Sweepstakes**”) is a social media Sweepstakes that begins on 5/28/24 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 5/31/24 at 11:59:59 PM (ET) (the “**Promotion Period**”).

Throughout the Promotion Period, eligible entrants will have the opportunity to “Like” the Sweepstakes post by the **Pringles®** Instagram account (**@pringles**) made on 5/28/24; post the Hashtag and tag a friend (as defined below) on Instagram in response to the Sweepstakes post; and follow **@pringles** and the **BrüMate** Instagram account (**@Brumate**); (the “**Submission**”), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.

By participating in the Sweepstakes and completing a Submission (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellanova (“**Sponsor**”), which shall be final and binding in all respects.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Instagram. Limit of one (1) entry per person/account for the Promotion Period.

- Submissions must be posted to a non-private social Instagram account; Instagram accounts can be obtained for free at <http://www.instagram.com>;
