OFFICIAL RULES

1. **PROMOTION DESCRIPTION:** The *Pringles*™ x *Smarties*® **Valentine's Day Giveaway** (the "**Sweepstakes**") is a social media Sweepstakes that begins on 2/13/24 at 12:00:00 AM Eastern Time ("**ET**") and ends on 2/15/24 at 11:59:59 PM (ET) (the "**Promotion Period**").

Throughout the Promotion Period, eligible entrants will have the opportunity to "like" the Sweepstakes photo posted by the *Pringles*® Instagram account (**@Pringles**) or the *Smarties*® Instagram account (**@Smarties**); post the Hashtag and tag a friend (as defined below) on Instagram in response to the Sweepstakes post on 2/13/24 by **@Pringles** or **@Smarties** (the "**Submission**"), as more fully set forth below. There will be one (1) Grand Prize winner in the Sweepstakes that will be randomly selected at the conclusion of the Promotion Period.
